<b>Explanation of Rule(s)</b>	<p><b>Income and ownership interests.</b> An applicant may be exempted from reporting the information otherwise required by RCW <a href="#">42.17A.710</a> (1)(f) and (g), if:</p> <p>(i) Public disclosure would violate any legally recognized confidential relationship;</p> <p>(ii) The information does not relate to a business entity which would be subject to the regulatory authority of the office sought or held by the applicant in whole or in part;</p> <p>(iii) Such reporting would present a manifestly unreasonable hardship to the applicant including but not limited to adversely affecting the competitive position of an entity in which the applicant had an interest of ten percent or more as described in RCW <a href="#">42.17A.120</a>; and</p> <p>(iv) The interest in question would present no actual or potential conflict with the performance of the duties of the office sought or held.</p>

<b>Reason(s) for Modification (as stated by filer)</b>	<ul style="list-style-type: none"> <li>• Mr. Seibert is requesting a renewal of a reporting modification that exempts him from disclosing the business and other governmental customers that paid \$12,000 or more during 2018 to Tootsie Roll Industries, Inc. (Tootsie Roll).</li> <li>• Mr. Seibert is a Director of Tootsie Roll. He stated that neither he nor his spouse had an ownership interest of 10% or more in the</li> </ul>

	<p>company during 2018. He said he is not involved in day-to-day operations of the company and does not have direct access to customer information.</p> <ul style="list-style-type: none"><li>• Mr. Seibert stated that Tootsie Roll is an international company engaged in the manufacture and sale of confectionary products (such as Tootsie Rolls, Mason Dots, Junior Mints, etc.) to approximately 15,000 retailers &amp; distributors in the United States and foreign countries. The company had annual sales of over \$500 million and approximately 2,000 employees.</li><li>• Mr. Seibert indicated that compiling the customer information would be a hardship on the company. He also stated that the candy industry is highly competitive and that Tootsie Roll considers its customer lists to be proprietary in nature.</li></ul>
<b>Other Issues</b>	<p>Mr. Seibert reported no payments from the City of Clyde Hill to Tootsie Roll Industries, Inc. in 2018.</p> <p>Mr. Seibert has agreed to recuse himself if a matter came before him involving a conflict of interest between Tootsie Roll Industries, Inc. and the City of Clyde Hill.</p> <p>Mr. Seibert has reviewed his initial reporting modification request and any subsequent renewal requests and has certified that there are no changes to the facts related to his request.</p>
