Explanation of Rule(s)	<p>Income and ownership interests. An applicant may be exempted from reporting the information otherwise required by RCW 42.17A.710 (1)(f) and (g), if:</p> <p>(i) Public disclosure would violate any legally recognized confidential relationship;</p> <p>(ii) The information does not relate to a business entity which would be subject to the regulatory authority of the office sought or held by the applicant in whole or in part;</p> <p>(iii) Such reporting would present a manifestly unreasonable hardship to the applicant including but not limited to adversely affecting the competitive position of an entity in which the applicant had an interest of ten percent or more as described in RCW 42.17A.120; and</p> <p>(iv) The interest in question would present no actual or potential conflict with the performance of the duties of the office sought or held.</p> <p>Applicants whose spouse or registered domestic partner creates a reporting obligation for the applicant. When an applicant is required to report the activities of an entity solely because the applicant's spouse or registered domestic partner held an office, directorship, general partnership or ownership interest in the entity and the applicant does not have direct knowledge of the information that must be reported, the applicant may be allowed to satisfy the disclosure requirements of RCW 42.17A.710 (1)(g)(ii) and WAC 390-24-020 by disclosing reportable customers from whom compensation in excess of the disclosure threshold established under RCW 42.17A.710 (1)(g)(ii) has been received as follows:</p> <p>(A) All payments made by the agency or jurisdiction in which the applicant seeks or holds office to the entity;</p> <p>(B) The business and other governmental customers or clients of the applicant's spouse/domestic partner and of the entity of which the applicant is aware; and</p> <p>(C) Any other business and other governmental customers or clients of the entity whose identities are known to the applicant and whose interests are significantly affected by the agency or jurisdiction in which the applicant seeks or holds office.</p> <p>The commission may apply (e)(i) through (iii) of this subsection when the applicant's spouse/domestic partner is a lawyer, judge, or motor vehicle dealer.</p>

Reason(s) for Modification (as stated by filer)	<ul style="list-style-type: none">• Mr. Butler is requesting a renewal of the reporting modification that would exempt him from disclosing the business customers that paid \$12,000 or more during calendar year 2017, to Anytime Labor, LLC (dba LaborMax Staffing), a temporary staffing firm with three locations in Washington.• Mr. Butler is owner/operator of LaborMax Staffing with a 1% ownership and his spouse, Mindy Butler, has a 29% ownership interest.• Mr. Butler stated that in his role as owner and operator of LaborMax Staffing he is both aware of the customers and is involved in the day to day operations.• Mr. Butler stated that LaborMax Staffing has approximately 80 clients, 14 full time employees, 200 temporary employees with annual sales of \$5 million in 2017.• Mr. Butler stated that LaborMax Staffing has approximately 30 to 35 reportable business customers. He confirmed that there are no reportable governmental customers.• Mr. Butler stated that a list of LaborMax Staffing's customers is not publically available.• Mr. Butler stated that publishing the reportable business customers would put LaborMax Staffing at a serious competitive disadvantage by making the list of customers available to competitors.• Mr. Butler stated the Granite Falls School District does no business with LaborMax Staffing.• Mr. Butler stated that LaborMax Staffing has no contracts with public agencies so he does not face conflicts of interest with his position on the Granite Falls School Board.
