<b>Explanation of Rule(s)</b>	<p><b>Personal residence - Real property.</b> Regarding reporting the information otherwise required by RCW <a href="#">42.17A.710</a> (1)(h) through (k):</p> <p>(i) Under WAC <a href="#">390-24-200</a>, the filer shall list the street address of each parcel, the assessor's parcel number, the abbreviated legal description appearing on property tax statements, or the complete legal description. Each property description shall be followed by the name of the county in which the property is located.</p> <p>(ii) No modification will be necessary if the filer describes the real property using one of the alternatives in WAC <a href="#">390-24-200</a>, plus the name of the county.</p> <p>(iii) A modification will be required if the filer seeks some other means to describe reportable real property including the personal residence of the filer. The commission may consider a modification, for example, when the filer or his or her immediate family member has received a threat, has a no contact order, or presents a similar personal safety concern.</p> <p>A prospective modification to allow nondisclosure of a residential address may be granted if the applicant or an immediate family member has received a threat, been issued a no contact order or presents a similar personal safety concern.</p>

<b>Reason(s) for Modification (as stated by filer)</b>	<ul style="list-style-type: none"><li>• Judge Doyle is requesting a reporting modification that would exempt her from reporting real estate, including street address, parcel number, or legal description, for her residential address on her Personal Financial Affairs Statement covering calendar year 2018.</li><li>• Judge Doyle has served as a judge for more than 20 years. She stated that has made many hundreds of criminal, family law and parental rights decisions that could provide persons with a motive to retaliate.</li><li>• Judge Doyle stated that in her role as Assistant Chief Criminal Judge from 2011 to 2012, she came in direct contact with over 100 persons each week accused of felonies, some violent offenders.</li><li>• Judge Doyle was a victim of direct threats made by Mr. James Wilks, who listed her as a judge on his “hit list”. Mr. Wilks was charged and convicted of intimidating a judge as well as other charges while in custody. Mr. Wilks was scheduled for release in 2016.</li></ul>
<b>Other Issues</b>	<p>Judge Doyle disclosed creditor information, payments terms, security given and mortgage amounts for her personal residence.</p> <p>Judge Doyle has agreed to recuse herself if a matter came before her involving a conflict of interest between her personal residence and King County Superior Court.</p>
