Explanation of Rule(s)	Lawyers and law firms (when applicant is an incumbent or candidate and acts alone or as part of a governing body, board, or commission). An applicant may be allowed to satisfy the reporting requirements of RCW 42.17A.710 (1)(g)(ii) and WAC 390-24-020 by disclosing reportable clients from whom compensation has been paid in excess of the reporting threshold as follows: (A) The names of the business clients for whom the applicant has done legal work; (B) Other clients of the law firm whose interests are significantly affected by the applicant's actions as an elected or appointed official or whose actions will be affected by the applicant's action should the applicant be elected whose identities become known to the applicant through any means; (C) The names of the clients of the law firm who are listed in Martindale Hubbell, the firm's resume, web site, or similar promotional materials; and (D) Governmental clients that have done business with the law firm. An applicant may also be required to disclose all business customers from whom compensation in excess of the reporting threshold has been received whose identities are publicized or referenced in documents open for public inspection at the courts, in administrative hearings, at proceedings conducted by public agencies, or are a matter of public knowledge in other similar public forums. Background	Ms. Durkan has disclosed the identity of clients for whom she did legal work during 2017. She has also disclosed government agencies for whom Hillis Clark Martin & Peterson performed legal work in 2017. Ms. Durkan has confirmed that there were no payments made by WSU to Hillis Clark Martin & Peterson in 2017.
Reason(s) for Modification (as stated by filer)	 Ms. Durkan is a partner of Hillis Clark Martin & Peterson, PS, a private law firm based in Seattle. She has less than 10% ownership and holds the title of "Vice President" and "Director" but does not participate in day-to-day management decisions, major firm decisions, budget decisions or changes to firm policies. Ms. Durkan is requesting a reporting modification that would exempt her from listing the business customers that made payments of \$12,000 or more to the law firm of Hillis Clark Martin & Peterson, PS, during 2017. Ms. Durkan stated that during 2017, Hillis Clark Martin & Peterson employed 76 employees total including 46 attorneys and performed legal work for more than 1,000 clients. In 2017, Ms. Durkan stated there were 221 clients that paid fees of more than \$12,000.
Other Issues	Ms. Durkan stated that if any of her firm's clients were before Washington State University on any matter in which she had decision-making authority she would disclose the relationship and recuse
	herself.
