<b>Explanation of Rule</b>	<p><b>Income and ownership interests.</b> An applicant may be exempted from reporting the information otherwise required by RCW <a href="#">42.17A.710</a> (1)(f) and (g), if:</p> <p>(i) Public disclosure would violate any legally recognized confidential relationship;</p> <p>(ii) The information does not relate to a business entity which would be subject to the regulatory authority of the office sought or held by the applicant in whole or in part;</p> <p>(iii) Such reporting would present a manifestly unreasonable hardship to the applicant including but not limited to adversely affecting the competitive position of an entity in which the applicant had an interest of ten percent or more as described in RCW <a href="#">42.17A.120</a>; and</p> <p>(iv) The interest in question would present no actual or potential conflict with the performance of the duties of the office sought or held.</p>

<b>Reason(s) for Modification (as stated by filer)</b>	Mr. Hill is requesting a renewal of the reporting modification that would exempt him from reporting the business and other governmental customers that paid \$12,000 or more during 2016 to the following entities for which he serves as a director or trustee: the Seattle Foundation, Habitat for Humanity, Pinchot University, MODA, Inc., Puget Sound Public Radio (dba KUOW) and Seattle City Club.

The Seattle Foundation

Mr. Hill serves on the Seattle Foundation's Board of Directors and the Investment Committee. Seattle Foundation is a non-profit organization with a \$10 million annual budget and has a 27 member Board of Directors.

Mr. Hill stated that it is not possible for him to report all of the payments the Seattle foundation has received that exceed \$12,000 and it would be a hardship to ask the organization to produce such a report.

Mr. Hill stated that there is a connection between the Seattle Foundation and Seattle Community Colleges.

Habitat for Humanity

Mr. Hill serves as a board member of Habitat for Humanity. Habitat for Humanity is a non-profit organization with a \$7 million annual budget and has a 14 member board.

Mr. Hill stated that it is not possible for him to report all of the payments Habitat for Humanity has received that exceed \$12,000 and it would be a hardship to ask the organization to produce such a report.

Mr. Hill stated that there is a connection between Habitat for Humanity and Seattle Community Colleges.

Pinchot University

Mr. Hill is a faculty member and serves as the Faculty Representative on the Board of Pinchot University. Pinchot University is a private graduate university offering an MBA in Sustainable Business. It has a \$3 million annual budget and has a 14 member Board.

Mr. Hill stated that it is not possible for him to report all of the payments Pinchot University has received that exceed \$12,000 and it would be a hardship to ask the organization to produce such a report.

Mr. Hill stated that there is a connection between the Pinchot University and Seattle Community Colleges.

MODA, Inc.

Mr. Hill serves as a board member of MODA, Inc. MODA, Inc. is an Oregon based dental and health insurance organization with a 14 member board.

Mr. Hill stated that it is not possible for him to report all of the payments MODA, Inc. has received that exceed \$12,000 and it would be a hardship to ask the organization to produce such a report.

Seattle City Club is a non-profit organization with a 17 member board.</p> <p>Mr. Hill stated that it is not possible for him to report all of the payments Seattle City Club has received that exceed \$12,000 and it would be a hardship to ask the organization to produce such a report.</p> <p>Mr. Hill stated that there is a connection between Seattle City Club and Seattle Community Colleges.</p>
