An applicant may be exempted from reporting the information otherwise required by RCW 42.17A.710 (1)(f) and (g), if:</p> <p>(i) Public disclosure would violate any legally recognized confidential relationship;</p> <p>(ii) The information does not relate to a business entity which would be subject to the regulatory authority of the office sought or held by the applicant in whole or in part;</p> <p>(iii) Such reporting would present a manifestly unreasonable hardship to the applicant including but not limited to adversely affecting the competitive position of an entity in which the applicant had an interest of ten percent or more as described in RCW 42.17A.120; and</p> <p>(iv) The interest in question would present no actual or potential conflict with the performance of the duties of the office sought or held.</p>

Reason(s) for Modification (as stated by filer)	<ul style="list-style-type: none"> • Mr. Jambor is requesting a reporting modification that would exempt him from disclosing the business customers that paid \$12,000 or more during calendar year 2015 to Ekone Oyster Co., of which he is president a co-owner with his spouse. • Mr. Jambor stated that Ekone Oyster Co. is a family owned business with annual sales of \$5 million, 47 employees and over 50 accounts. He stated that at least 10 customers would be reportable. • Mr. Jambor stated that disclosing the reportable customers of Ekone Oyster Co. would cause a competitive disadvantage by allowing competitors to have access to the customer list. • Mr. Jambor stated that all reportable customers do business outside of Pacific County where the Port of Willapa is located.

Other Issues	<p>Mr. Jambor stated that Ekone Oyster Co. does no business with the Port of Willapa and that there are no governmental customers.</p> <p>Mr. Jambor stated that if an actual or potential conflict of interest occurred he would recuse himself.</p>
Staff Recommendations	Approve renewal of the requested reporting modification with no change.
