	Mr. Pedersen stated that McKinstry Company, LLC, has 500 employees.
	Mr. Pedersen stated that sales figures for McKinstry Company, LLC, are not publicly available.
	Mr. Pedersen stated that the commercial construction industry is highly competitive. Providing detailed aggregated information about governmental and business clients of the company would put the company at a serious completive disadvantage. It is likely that competitors would review and use that information to the disadvantage of McKinstry Company, LLC.
	Mr. Pedersen stated that he has a 1% ownership interest.
