Reason(s) for Modification (as stated by filer)	<ul style="list-style-type: none"> • Judge Wilcox is requesting a reporting modification that would exempt her from disclosing her residential address, parcel number, or legal description on all filings submitted to the Public Disclosure Commission. • Judge Wilcox initially filed campaign finance disclosure reports and a personal financial affairs statement in 2010 as a candidate for Thurston County District Court Judge. After being elected in 2010, Judge Wilcox filed an annual F-1 statement in 2011, 2012, and 2013. • The residential parcel number was disclosed on F-1 reports filed in 2010 and 2012. (The F-1A form was used in 2012.) The residential address does not appear on any reports filed by Judge Wilcox. • Judge Wilcox stated that she sentenced an individual in 2011 after he plead guilty to Theft in the Third Degree. • Judge Wilcox stated that she received a handwritten letter from the offender with explicit threats against her and her family. She described other specific activities of the offender that were intended to harm her.

	<ul style="list-style-type: none">• Judge Wilcox stated that the offender has a criminal record for crimes of violence and that neither prosecution nor incarceration has deterred him from reoffending.• Judge Wilcox stated that she does not want to disclose the location of her residence on reports that she files with the Public Disclosure Commission out of concern for her safety. Furthermore, Judge Wilcox wants the address and parcel number redacted from all reports that have been previously filed.
Staff Recommendations	<p>Approve the requested reporting modification to exempt Judge Kalo Wilcox from disclosing a residential address, real estate parcel number, or legal description on the Personal Financial Affairs Report filed in 2013.</p> <p>Approve the request to redact the parcel number from Personal Financial Affairs Reports filed by Kalo Wilcox in 2010 and 2012.</p>
