<b>Reason(s) for Modification (as stated by filer)</b>	<ul style="list-style-type: none"> <li>• Judge Lauren King is requesting a partial reporting modification that would exempt her from disclosing reportable information related to her residential address on her Personal Financial Affairs Statement (F-1 report) filed for calendar year 2020, due to safety concerns.</li> <li>• Judge King stated that her request is being made due to the potential harm disclosure of reportable information related to her residence could cause to her and her family. She further stated that she has a current no-contact agreement in effect due to a specific threat and has described additional precautions she has taken to mitigate the risk.</li> </ul>

<b>Other Issues</b>	<p>As a current judicial office holder, Judge King is able to utilize the address disclosure alternative described in RCW 42.17A710(2)(a).</p> <p>PDC staff have informed Judge King of the residential address alternatives set forth in <a href="#">WAC 390-24-200</a> and of the additional disclosure requirements of <a href="#">RCW 42.17A.700</a>.</p> <p>Judge King is planning to provide additional information verbally to the Commission regarding her request.</p> <p>Judge King's records would be exempt from public disclosure if the Commission finds in accordance with <a href="#">RCW 42.17A.120</a> and <a href="#">WAC 390-28-080</a> that disclosure of such information would present a personal risk to a reasonable person.</p>
