<b>Explanation of Rule(s)</b>	<p><b>Income and ownership interests.</b> An applicant may be exempted from reporting the information otherwise required by RCW <a href="#">42.17A.710</a> (1)(f) and (g), if:</p> <ul style="list-style-type: none"> <li>(i) Public disclosure would violate any legally recognized confidential relationship that serves a legitimate business interest;</li> <li>(ii) The information does not relate to a business entity which would be subject to the regulatory authority of the office sought or held by the applicant in whole or in part;</li> <li>(iii) Such reporting would present a manifestly unreasonable hardship to the applicant including but not limited to adversely affecting the competitive position of an entity in which the applicant had an interest of ten percent or more as described in RCW <a href="#">42.17A.120</a>; and</li> <li>(iv) The interest in question would present no actual or potential conflict with the performance of the duties of the office sought or held.</li> </ul>
