Reason(s) for Modification (as stated by filer)	<ul style="list-style-type: none"> • Judge Robinson is requesting a renewal of a reporting modification that would exempt her from disclosing the business customers that paid \$10,000 or more during 2013 to K & H Printers-Lithographers, Inc. (K&H). • Judge Robinson's spouse, Steven Hopp, is CFO and Senior Vice President of K&H. The company is based in Everett, Washington and provides printing, binding, and election services for business and government customers. • Judge Robinson stated that she does not hold a position with K&H, nor does she perform any duties for the entity. She stated she does not have access to customer lists. • Judge Robinson stated that the printing business is very competitive and K&H's customer lists are proprietary information with independent economic value. She also stated that it would be very time consuming for the company to sort through their customer lists in order to determine which customers would be reportable. • Judge Robinson stated that she would recuse herself in any case that involves K&H, their customers that she knows about, or any of their business interests.
Other Issues	Judge Robinson disclosed all of the governmental entities for whom K&H does work. She reported all of the business customers of which she is aware. She also disclosed the customers appearing on K&H's website.
Staff Recommendations	Approve renewal of the reporting modification with no change.

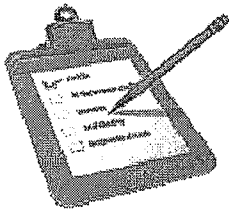

However, a complete list of K&H's clients, and how much money it receives from each, would likely affect adversely the competitive position of the company since it is engaged in a highly competitive business.

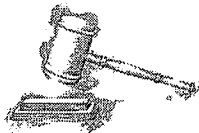

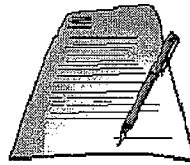

On April 25, 2013, the application of Palmer Robinson, 516 Third Avenue C-203, Seattle, Washington 98104, for a modification of the reporting requirements of RCW 42.17A.710 was brought before the Public Disclosure Commission.

Consideration of the request was made pursuant to RCW 42.17A.120 and chapter 390-28 WAC by the Commission. The proceedings were held in Room 206, Evergreen Plaza Building, 711 Capitol Way, Olympia, Washington, 98504. The applicant, Palmer Robinson, by Modification Application, requested a renewal of the reporting modification that would exempt her from disclosing the business customers that paid \$10,000 or more during 2012 to K & H Printers-Lithographers, Inc. (K&H).

The Commission was provided with a certification from Judge Robinson waiving her personal appearance at the hearing and stating that the facts contained in the request are true and accurate.

FINDINGS OF FACT

Based upon the Modification Application, the Commission makes the following Findings of Fact:

1. Judge Robinson has previously been granted the requested reporting modification, the most recent being Order No. 3048.
2. Judge Robinson serves as a Superior Court Judge for King County. Her elected term of office expires in December 2016.
3. Judge Robinson's spouse, Steven Hopp, is CFO, Senior Vice President, of K&H. The company is based in Everett, Washington and provides printing, binding, and election services for business and government customers.
4. Judge Robinson stated that she does not hold a position with K&H, nor does she perform any duties for the entity. She stated she does not have access to customer lists.
5. Judge Robinson stated that the printing business is very competitive and K&H's customer lists are proprietary information with independent economic value. She also stated that it would be very time consuming for the company to sort through their customer lists in order to determine which customers would be reportable.
6. Judge Robinson stated that she would recuse herself in any case that involves K&H, their customers that she knows about, or any of their business interests.

7. Judge Robinson disclosed all of the governmental entities for whom K&H does work. She reported all of the business customers of which she is aware. She also disclosed the customers appearing on K&H's website.

CONCLUSIONS OF LAW

Having made these Findings of Fact, the Commission makes the following Conclusions of Law:

1. Literal compliance with all the provisions of the reporting requirements of RCW 42.17A.710 would work a manifestly unreasonable hardship on the applicant.
2. Limited suspension or modification of the reporting requirements as specified in the Order would not frustrate the purposes of the Act in this particular case.

ORDER

Having made these Findings of Fact and Conclusions of Law, the Commission issues the following Order:

For the Statement of Personal Financial Affairs covering 2012 required to be filed with the Public Disclosure Commission between January 1 and April 15, 2013:

1. The applicant shall report all payments made by King County Superior Court to K & H Printers-Lithographers, Inc. during the reporting period.
2. The applicant may satisfy the reporting requirements of RCW 42.17A.710 without reporting the reportable business customers of K & H Printers-Lithographers, Inc., except that she must disclose the reportable information of which she is aware.
3. The applicant shall disclose the reportable business and other governmental customers or clients of K & H Printers-Lithographers, Inc. during the reporting period, whose identities are known to the applicant and whose interests are significantly affected by King County Superior Court, to the extent not otherwise disclosed in (1) and (2).
4. In all other matters required to be reported, the applicant shall comply in full with the reporting requirements of RCW 42.17A.
