Reason(s) for Modification (as stated by filer)	<ul style="list-style-type: none"> • Judge Phillips is requesting a renewal of the reporting modification that would exempt him from reporting his personal residential address information, including street address, parcel number, or legal description, on his Personal Financial Affairs Statement for 2018. He is also requesting a renewal of the reporting modification that would exempt him from reporting the address information, including street address, parcel number, or legal description of an undeveloped lot located outside of King County. • Judge Phillips stated that as a Kent Municipal Court Judge, his duties include hearing and disposing of criminal cases, civil infractions, petitions for orders of protection, and tow impound hearing. His duties also include adopting local court rules and administrative orders, hiring staff, and setting court and probation policy and procedures. • Judge Phillips stated that he has been threatened with death or injury on at least three occasions in the past by defendants that have appeared before him. He stated for safety and security concerns he does not want to disclose his residential address and the address of an undeveloped parcel of land he owns, on which he plans to build a vacation home.

Other Issues

Judge Phillips has agreed to recuse himself if a matter came before him involving a conflict of interest between his personal residence and the additional undeveloped lot referenced above, and the Kent Municipal Court.

Judge Phillips has reviewed his initial reporting modification request and any subsequent renewal requests and has certified that there are no changes to the facts related to his request.
