Subject: Proposed revision to the Annual Treasurer's Statement (T1)

Issue Facing the Commission:

The Compliance and Enforcement Division has received 14 new complaints against government units for failure to file an Annual Treasurer's Statement (T1 Form) by the April 15 deadline.

Of the 346 localities required to file a T1, we have received forms from only about 100 this year. Some localities are missing T1 statements for multiple years. Jurisdictions trying to cure missing filings face a dilemma since our current form does not allow for situations where previous treasurers or others with fiduciary responsibility are no longer in office.

Background:

State law requires treasurers for Washington State, counties, public utility districts, port districts, and cities or towns with population exceeding 1,000 to file a T1 statement annually. The statement must indicate that no public funds under their control during the reporting period were invested in a financial institution in which they held "an office directorship, partnership interest, or ownership interest." RCW 42.17A.570(1).

If treasurers did invest public funds in such a financial institution, they are required to list the name and address of the institution, aggregate sum of time and demand deposits for the year, and the highest balance held at any time during the reporting period. RCW 42.17A.750(2).

There are situations in which the previous treasurer is unavailable because he or she has retired, died, or even been incarcerated.

Staff Proposal:

Allow Commission Staff to begin circulating the attached proposed T1 form to facilitate retroactive compliance after a new treasurer takes office. It would allow current treasurers to certify that they had no control over public funds during the reporting period in question and that the previous official is no longer in office. They also could supply contact information for predecessors if known.

Authority:

Most of our forms are contained as images within various sections of Title 390 WAC, making even the slightest of proposed changes a time- and resource-intensive process.

Fortunately, the rule containing this form (WAC 390-24-300) was repealed in February 1984, and never recodified. This grants us considerable flexibility to respond.

- Public Utility District Treasurers
- Port District Treasurers
- Treasurers of Incorporated Cities or Towns (whose population exceeds 1000)

When To File – <u>Between January 1 and April 15 of each calendar year</u>. The T1 must be filed each year to certify the previous calendar year.

Where To File – Send the **original to PDC** at the address on the reverse side. Keep a copy for the your government unit or special purpose district's records.
