Explanation of Rule(s)	<p>Applicants whose spouse or registered domestic partner creates a reporting obligation for the applicant. When an applicant is required to report the activities of an entity solely because the applicant's spouse or registered domestic partner held an office, directorship, general partnership or ownership interest in the entity and the applicant does not have direct knowledge of the information that must be reported, the applicant may be allowed to satisfy the disclosure requirements of RCW 42.17A.710 (1)(g)(ii) and WAC 390-24-020 by disclosing reportable customers from whom compensation in excess of the disclosure threshold established under RCW 42.17A.710 (1)(g)(ii) has been received as follows:</p> <p>(A) All payments made by the agency or jurisdiction in which the applicant seeks or holds office to the entity;</p> <p>(B) The business and other governmental customers or clients of the applicant's spouse/domestic partner and of the entity of which the applicant is aware; and</p> <p>(C) Any other business and other governmental customers or clients of the entity whose identities are known to the applicant and whose interests are significantly affected by the agency or jurisdiction in which the applicant seeks or holds office. The commission may apply (e)(i) through (iii) of this subsection when the applicant's spouse/domestic partner is a lawyer, judge, or motor vehicle dealer.</p>

Reason(s) for Modification (as stated by filer)	<ul style="list-style-type: none"> • Mr. White is requesting a reporting modification that would exempt him from disclosing the business customers that paid \$12,000 or more during calendar year 2017, to Western Polymer Corporation. • Mr. White's spouse, Lynn Townsend-White serves as CEO of Western Polymer Corp. with a 100% ownership interest.

	<ul style="list-style-type: none">• Mr. White stated that he has no ownership interest in the company and is not involved in the day to day operations.• Mr. White stated that Western Polymer Corp. has 60 employees.• Mr. White stated that the exact number of Western Polymer Corp. customers are unknown to him but he believes approximately 5 to 10 would meet the reporting threshold. He also stated that there are no reportable governmental customers.• Mr. White stated that Western Polymer Corp. is a privately held company and that a list of its customers is not publically available.• Mr. White stated that the food grade potato starch industry is highly competitive and publishing the reportable business customers would put Western Polymer Corp. at a serious competitive disadvantage.• Mr. White stated the Grant County Hospital District does no business with Western Polymer Corp.
Other Issues	Mr. White disclosed that if any matter came before him involving Western Polymer Corp., or its customers, that he would recuse himself.
Staff Recommendations	Approve renewal of the reporting modification with no change.
