<b>Reason(s) for Modification (as stated by filer)</b>	<ul style="list-style-type: none"> <li>• Mr. White is requesting a reporting modification that would exempt him from disclosing the business customers that paid \$12,000 or more during calendar year 2014, to Western Polymer Corporation.</li> <li>• Mr. White's spouse, Lynn Townsend-White serves as CEO of Western Polymer Corp. with an ownership interest of over 50%.</li> <li>• Mr. White stated that he has no ownership interest in the company and is not involved in the day to day operations.</li> <li>• Mr. White stated that Western Polymer Corp. is a company that sells potato starch to the paper industry and is located in Moses Lake.</li> <li>• Mr. White stated that Western Polymer Corp. has 60 employees and has annual sales of approximately \$10 million.</li> <li>• Mr. White stated that the exact number of Western Polymer Corp. customers are unknown to him but he believes approximately 5 to 10 would meet the reporting threshold. He also stated that there are no reportable governmental customers.</li> <li>• Mr. White stated that Western Polymer Corp. is a privately held company and that a list of its customers is not publically available.</li> <li>• Mr. White stated that the potato starch industry is highly competitive and publishing the reportable business customers would put Western Polymer Corp. at a serious competitive disadvantage.</li> <li>• Mr. White stated the Grant County Hospital District does no business with Western Polymer Corp.</li> </ul>

<b>Other Issues</b>	Mr. White disclosed that if any matter came before him involving Western Polymer Corp., or its customers, that he would recuse himself.
<b>Staff Recommendations</b>	Approve renewal of the reporting modification with no change.
