Reason(s) for Modification (as stated by filer)	<ul style="list-style-type: none"> • Mr. Fleck is requesting a reporting modification that would exempt him from disclosing the business customers that paid \$10,000 or more during the previous 12 months to Green Crow Corporation (GCC) and Green Crow Timber (GCT). Mr. Fleck serves on the Board of Directors for both entities. He has no ownership interest in either entity. • Mr. Fleck stated that Green Crow Corporation (GCC) and Green Crow Timber (GCT) are privately owned family companies that operate a business structure that is known as Green Crow which is headquartered in Port Angeles. • Mr. Fleck disclosed that Green Crow Corporation (GCC) and Green Crow Timber (GCT) are timber companies. • Mr. Fleck stated that Green Crow Corporation (GCC) and Green Crow Timber (GCT) have a combined total of 50 employees. • Mr. Fleck stated that Green Crow Corporation (GCC) and Green Crow Timber (GCT) have annual sales of approximately \$30 million and hundreds of customers. • Mr. Fleck stated that the timber industry is highly competitive and publishing the reportable business customers would put both companies at a serious competitive disadvantage. • Mr. Fleck also stated that Green Crow Corporation (GCC) and Green Crow Timber (GCT) may have confidentiality agreements and obligations with their customers that could be violated and/or jeopardized by disclosure. • Mr. Fleck is not involved in the day-to-day operations of Green Crow Corporation (GCC) and Green Crow Timber (GCT).
