Reason(s) for Modification (as stated by filer)	<ul style="list-style-type: none"> • Ms. Adams is requesting a reporting modification that would exempt her from disclosing the business customers that paid \$12,000 or more during calendar year 2014, to Systems Consulting, LLC. • Ms. Adams is the president of Systems Consulting, LLC with an ownership interest of 51%. Her spouse, Everette W. Adams III, is CEO and has a 49% ownership interest. • Ms. Adams stated that she is involved in the day to day operations of Systems Consulting, LLC. • Ms. Adams stated that Systems Consulting, LLC is a professional services company located in Tacoma providing quality control management and project management, on large capital projects in the construction industry. • Ms. Adams stated that Systems Consulting, LLC has annual sales of approximately \$1.7 million and has 22 employees. • Ms. Adams stated that nine customers of Systems Consulting, LLC would meet the reporting threshold. She also stated that there are no reportable governmental customers. • Ms. Adams stated that Systems Consulting, LLC is a privately held company and that a list of its customers is not publically available. • Ms. Adams stated that the construction industry is highly competitive and that disclosing the reportable business customers would put Systems Consulting, LLC at a serious competitive disadvantage.

Other Issues	Ms. Adams disclosed that Systems Consulting, LLC do not do business with Tacoma Community College.
