An applicant may be exempted from reporting the information otherwise required by RCW 42.17A.710 (1)(f) and (g), if:</p> <p style="padding-left: 40px;">(i) Public disclosure would violate any legally recognized confidential relationship that serves a legitimate business interest;</p> <p style="padding-left: 40px;">(ii) The information does not relate to a business entity which would be subject to the regulatory authority of the office sought or held by the applicant in whole or in part;</p> <p style="padding-left: 40px;">(iii) Such reporting would present a manifestly unreasonable hardship to the applicant including but not limited to adversely affecting the competitive position of an entity in which the applicant had an interest of ten percent or more as described in RCW 42.17A.120; and</p> <p style="padding-left: 40px;">(iv) The interest in question would present no actual or potential conflict with the performance of the duties of the office sought or held.</p> <p style="text-align: center;">Motor vehicle dealers. An applicant may satisfy the reporting requirements of RCW 42.17A.710 (1)(g) and WAC 390-24-020 by disclosing:</p> <p style="padding-left: 40px;">(A) All purchases and leases of vehicles, and purchases of parts and services from the dealership, by the agency or jurisdiction in which the applicant seeks or holds office;</p> <p style="padding-left: 40px;">(B) Other business and governmental entities that purchased or leased ten or more vehicles from the dealership;</p> <p style="padding-left: 40px;">(C) Business customers who paid in excess of twenty thousand dollars for the purchase of parts and/or service from the dealership; and</p> <p style="padding-left: 40px;">(D) Any other governmental entity that paid the dealership in excess of the disclosure threshold established under RCW 42.17A.710 (1)(g)(ii) for the purchase of parts and/or service.</p>
