Reason(s) for Modification (as stated by filer)	<ul style="list-style-type: none">• Ms. Plese is requesting a partial reporting modification that would exempt her from disclosing the business and other governmental customers that paid \$12,000 or more during the previous twelve months to KPC Enterprises, Inc. dba Plese Printing & Marketing, of which she is a 100% owner.• Ms. Plese stated that her request is being made due to confidentiality agreements for new customers, agreements for existing customers, staffing shortages and the fact that her computer system does not have the capability to generate a list of reportable customers.• Plese Printing & Marketing is located in Spokane and specializes in design services, sheet-fed full color printing, spot color printing, high speed digital black and white copying, high speed digital color copying, binding/finishing and complete in-house direct mail marketing.• Ms. Plese stated that Plese Printing & Marketing has annual sales between \$750,000 and \$900,000 and that her database has more than 4,000 clients in it.• Ms. Plese has disclosed on her candidate F-1 report all payments made by Spokane County to her business during the reporting period.
