Previously there was no business customer reporting obligation as an employee. • Ms. Frame states that releasing the list of customers would create a competitive disadvantage for the company. • Ms. Frame states that in 2022 revenue for BDS Planning & Urban Design Inc was \$1,983,807.79 and the company had 14 or fewer employees.
