Dear PDC;

I wish to give oral comments tomorrow, please. I also second Conner Edwards' concerns. I would also add that I want it clear - 2nd violation of not filing your forms and not responding to the PDC should mean a \$10K fine and attorney general referral. I am sick and tired of the contempt for campaign finance transparency by so many and annoyed that the same progressives lighting their hair on fire over AIPAC are not demanding the PDC be stronger.

Our democracy is under attack. I quote Estonian Prime Minister Kaja Kallas to you as my fellow NAFO fella in defense of Ukraine is in the news this week:

"We need to take care of the democratic relationship between the citizen and the state. As much as it is the individual responsibility of every citizen to care for democracy, it is the leaders who are responsible for keeping the rights of individuals and the rule of law at the center of governance. Leaders must also safeguard strong institutions in support of it.

"This is often not self-evident. Attacks on democratic institutions are on the rise – from within our own democracies as well as from outside."

The PDC is supposed to be a key democratic institution, and water is wet. But what good is a PDC that will not actually stand up and defend herself? Tsimerman is the arsonist, the Putin in our midst. The plan was to break him through fair enforcement of the law. People look to Tsimerman's cases and say, "Why should I care what the PDC does if I rent? The PDC can't do anything to me." This must change with <u>the current case</u>.

Warning letters and fines have not worked with Tsimerman, and collection agencies are not collecting. At least continual combat air patrols, outreach by state-level good government groups like the MRSC, and PDC reminders to politicians who own property have stopped Tsimerman's campaigning for the most part. So yes, the PDC may be failing this stress test, but many other good institutions are stepping up - like the City Council of Redmond.

I finally also wish to add that repeat offender Avrum (Alex) Tsimerman is being prosecuted for violating a no-trespass from the Bellevue Mall. I am attaching relevant files so your legal team can please consider weighing in with the Court. It should also be noted that Tsimerman claims to need an interpreter.
