

**Written Comment for July 11, 2024**  
**Brief Adjudicative Proceeding**

Commissioners:

At the upcoming BAP on Thursday, the Commission will hear a number of cases, mostly relating to filers who have failed to file C1 and F1 reports.

At BAPs, the Commission has the authority to impose penalties of up to \$1000.

Because the data (see below) shows that the current nominal suspended penalties being imposed are not having the intended effect of increasing compliance, I am urging the Commission to impose larger suspended penalties at BAPs. For instance, let's say that the Commission would normally impose a penalty of \$150 for a missing F1 with \$75 unsuspended (payable immediately) and \$75 suspended. I would suggest that the Commission should impose a penalty of \$75 unsuspended and \$925 suspended on the condition that they file the report and fully comply with the order.

**Why am I suggesting this?**

For background, when the Commission presides over an enforcement case and determines that a violation of RCW 42.17A has occurred, the Commission typically suspends some portion of the penalty. This suspension is usually conditioned on: i) prompt payment of the unsuspended penalty within 30 days, ii) the respondent filing the required reports that were missing, and iii) the respondent remaining in compliance with RCW 42.17A over the next four years.

My understanding is that the theory behind the unsuspended penalty is to provide a meaningful incentive for the respondents to come into compliance and remain in compliance. Put simply: if respondents pay their fine, file the required reports, and don't have any future violations, they can avoid a significant part of the penalty imposed (typically half of the overall penalty).

So, I wanted to crunch the numbers on how that theory works in reality, since I have never heard staff present any statistics on it to the Commission.

As it turns out, the agency's current approach is not working well.

**Methodology**

I pulled a dataset from the PDC's Open Data portal. I looked at all cases closed after 1/1/2022 where there was a penalty imposed by the Commission at a hearing and some portion of the penalty was suspended. There were a total number of 420 cases that met these criteria.

Of these 420 cases, only 195 respondents managed to successfully comply with the conditions of the order issued by the Commission and avoided having the suspended portion of their penalties becoming due. This equates to only a 46% "success" rate.

Of these 420 cases, 225 respondents failed to comply with the conditions of the order issued by the Commission and had the suspended penalty portion of their penalty become due. This equates to a 54% "failure" rate.

This failure rate is shocking.

For your reference, the spreadsheet of 420 cases pulled from the Open Data portal is attached to this e-mail.

Clearly, a change of some type to the agency's approach is needed. Increasing the suspended portion of penalties issued, so that they are less nominal and more significant, is a logical solution to consider. This change would require no additional agency resources and no additional statutory authority.

**What is the downside of this idea?**

The downside of this proposal is that respondents who don't comply with the orders issued by the Commission will have to pay a significantly higher cost for their noncompliance than they do currently. Instead of noncompliant filers paying say \$75 on average for failing to comply with the Commission's order, they would pay \$925.

That's a feature, not a glitch.

This proposal would establish a meaningful incentive for respondents to stay in compliance, send a message to the regulated community that noncompliance is unacceptable, and it would also help raise revenue for the agency.
