Today's Brief Adjudicative Proceeding (BAP) concerns 2023 candidates whom PDC staff allege have violated RCW 42.17A.235 and .240 by failing to file or timely file the required Post Election Receipts & Expenditure Summary (C-4 report) that was due to be filed with the PDC on September 11, 2023.

PDC staff have identified cases that were resolved through receipt of a signed Statement of Understanding, the missing report and penalty payment or have been resolved administratively¹. A list of resolved cases is appended to this document, see page 3.
